Show Information, Rules, Terms and Conditions:



- The Antique Bottle & War Relic Collectible Show & Sale is a rain or shine event, no refunds will be given.
- Berkeley Citizens, Inc. is a not-for profit agency serving people with developmental disabilities.
- The event will take place in a 25,000 sq. ft. building located just off the intersection of Hwy. 52 and Old Hwy. 52 South in Moncks Corner.
- The building is monitored for fire and security and will be manned overnight
- Parking for dealers, once unloaded, will be available in a near-by shopping center within a short walking distance
- The event will be advertised in local businesses, newspapers, web sites, trade show magazines, etc.
- Any & All Necessary Licenses, State and Local Taxes are the Responsibility of the Dealer, not Berkeley Citizens, Inc.
- Subletting or reselling your assigned space is not permitted.
- Only one (1) assistant, during set-up and the show, is allowed per dealer regardless of the number of tables.
- We allow tabletop collectables, but at least 50% of wares are to be bottles.
- Dealer agrees to truthfully represent their merchandise to buyers & conduct business with the highest of ethical standards.
- No drugs or alcoholic beverages may be brought into the show area or anywhere else on the premises of Berkeley Citizens, Inc.
- The Holiday Inn Express in Moncks Corner, as the host hotel, offers room discounts for an overnight stay for vendors.
- Smoking inside the building is prohibited.
- Food and drinks may be brought in for personal consumption, but not for sale.
- Concessions will be available during the show
- Dealer and assistant will be given dinner on Friday afternoon
- Dealers must remain set up for the full term of the show
- For safety and insurance purposes, objects, sale boxes, stands or other display equipment, large objects such as hand trucks, personal tables, etc. are not permitted in the aisles, between tables or in front of sales tables.
- Dangerously hot exhibit lighting such as halogen and propane, items that are stacked high that could fall, or items displayed low that could cause tripping, extremely sharp items or anything else that poses a danger to the public are not allowed inside the facility or on the grounds.
- All wall type back drops are limited to six (6) feet in height, although back drops are not required/recommended
- If electricity is needed, dealers must provide their own UL approved extension cord; all cords must be secured away from pedestrian walkways.
- We will provide table flags identifying you as the dealer that must be visible throughout the show.
- Sale prices are to be clearly marked.
- **Directions: From I-26 Columbia, take the Hwy 17A exit toward Moncks Corner. Follow 17A into Moncks Corner. At the intersection of Hwy 17A and Main Street/Hwy 6, turn right. At 1st stop light past the Railroad Tracks, turn right on to Hwy 52. After the 2nd stop light, turn right just past the 52 Gas Station and keep bearing right on the road between the back of the gas station and car wash. Berkeley Industries is at the end of the road.**
